CATTLE INFO: Please call ahead for your cattle.
When competitors don't call ahead to reserve their cattle, it puts the Colorado Reined Cowhorse Assn. in a difficult position ordering the correct number of livestock. This results in extra costs for the association and show management who strive to be fair in assigning the fresh and rerun cattle during the show. You can call up to 48 hours before the event to cancel your cow and not be charged. To order/cancel cattle - call CRCA Rep 303-828-3037.

**National Reined Cow Horse Association approved classes held Saturday in conjunction with the regular AQHA cow classes. AQHA Cowhorse held all three days.

- Show will payback 80% of entry fees according to the NRCHA Scale for classes with added money and 100% for classes with no added money. Checks mailed within 10 days of last day of show.
- Bracketed classes will run concurrently. One cattle fee will be charged for entries in more than one division.

Non Pro Limited and Youth Limited are a Box Only class, no down the fence. These classes are limited to riders who have not been down the fence more than 3 times per NRCHA Rules.
