## 2009 Rocky Mountain Quarter Horse Association Futurity Conditions

### General Conditions

1. The Open Futurity is open to all AQHA, APHA and ApHC registered horses meeting age requirements as specified. Except as otherwise noted, all Open Futurity conditions also apply to the Colorado Owned & Shown classes.
2. All futurity horses may be shown prior to futurity.
3. A photocopy of registration papers or breeders certificate must be included with each entry.
4. ABSOLUTELY NO REFUNDS IN THE CASE OF DEATH OR INJURY.
5. If a horse entered is unable to work or be shown, two veterinarian certificates as well as a \$50 fee will be required before a substitution can be made.
6. Non Pro classes are open to anyone who holds a current Amateur or Youth Card.
7. Change of ownership does not void a nomination for the RMQHA Futurities, but the seller must report all transfers of ownership to RMQHA secretary within ten (10) days of sale, except as noted in **Condition 8** for the Colorado Owned & Shown classes.
8. Colorado Owned & Shown classes must have both the owner and the exhibitor as residents of the State of Colorado on their memberships and identification by August 15, 2009. Additionally Colorado Ownership must be designated on the horse's original registration papers by August 15, 2009.
9. Owners and exhibitors must be or become current members in good standing of the RMQHA. Membership fee is \$45.00. NSBA membership of \$55.00 is required for all owners and exhibitors in NSBA classes.
10. Sixty percent (60%) of entries collected will be applied to the purse. Forty percent (40%) will be deducted to cover futurity expenses.
11. All classes are double judged, paying a total purse of 30% to the Judge 1, 30% to the Judge 2, and 40% to the top four (4) receiving highest overall points earned.
12. Ten entries or under in a class: 4 monies will be paid (40-30-20-10%). Eleven or more entries in a class: 6 monies will be paid (30-24-18-12-9-7%).
13. Point system used will be as follows to determine overall judges placing: (all classes)

1 <sup>st</sup> place – 8 points	5 <sup>th</sup> place – 4 points
2 <sup>nd</sup> place – 7 points	6 <sup>th</sup> place – 3 points
3 <sup>rd</sup> place – 6 points	7 <sup>th</sup> place – 2 points
4 <sup>th</sup> place – 5 points	8 <sup>th</sup> place – 1 point

Horses will be placed according to accumulated points. Ties will be broken by the posted tiebreaker judge for prizes only.  
Ties for money will be split equally by the number of horses tied for that placing.

14. **Payment Schedule for all Futurity Classes: Paid by August 1, 2009 – Entry Fee \$75.00; Paid by: September 1, 2009 – Entry Fee \$100.00; Paid on and after: September 2 - 11, 2009 (until 10:00 AM Friday September 11, 2009) - \$150.00. Late entry fee does not apply to the NSBA Incentive classes.**

### Halter Conditions

1. Weanlings are to be nominated by naming Sire, Dam, birthdate and sex (stallion, mare). Weanling geldings will be shown in the stallion division.
2. Unisex Longeline class will be judged 80% movement while on a longeline. (Max Time 1 ½ minutes shown at a walk, trot, and lope in both directions). 20% of score will be awarded on conformation.

### Performance Conditions

1. AQHA rules will govern the Hunter Under Saddle, Non Pro Western Pleasure, 2 Yr Old Western Pleasure, and 3 & 4 Yr Old Western Pleasure classes. NSBA guidelines and rules will also be followed in NSBA classes.
