Commercial Exhibitor space is available at the following shows on a limited basis and at the discretion of the individual RMQHA Show Committee. Please notify the show office of your arrival so that we may greet and direct you to your location.

- ▲ Each event is managed and operated under its own RMQHA Chairman and Show Committee.
- ▲ Show Committee does not guarantee location.
- ▲ **A space is not reserved until payment is received.** We cannot accept phone reservations.
- ▲ RMQHA accepts no liability for lost, stolen or damaged goods and property. **It is the commercial exhibitor's responsibility to carry and maintain proper liability and comprehensive insurance coverage.**
- ▲ It is the commercial exhibitor's responsibility to collect any required sales tax on sales and forward to the proper government entity.
- ▲ Show Committee reserves the right to refuse space to any commercial exhibitor or to limit types of exhibitors.
- ▲ There is no equipment furnished with space. **Any tables, chairs, etc. requested will be billed.**
- ▲ Commercial Exhibitors are to provide security measures for their own space.
- ▲ **A deposit of 50% is due upon submission of request for space.** Be specific with size and type of spot desired. Balance is due 14 days prior to first show date. Failure to meet the second payment deadline may result in loss of space and will incur a \$25 late payment fee.
- ▲ **There are no refunds for any reason.**

1. **RMQHA Denver Circuit - National Western Events Center, Denver, CO.** January 2 thru January 7, 2010.

Location: Warmup Arena area - Indoor. 10x10 - \$150; 10x20 - \$250; 10x25 - \$300; 10x30 - \$350; 10x40 - \$400.

Move in: no earlier than 10 a.m. on December 31 and no later than 3:00 p.m. on January 2.

Move out for this location is Thursday, January 7 at 3 p.m.

Location: Concourse - Mezzanine Level - 10 x 10 - \$75; 10 x 20 - \$100.

Move in: no earlier than 10 a.m. on December 31 and no later than 3:00 p.m. on January 1.

Move out: is Tuesday, January 5 at 8 p.m. There can be no sawing, electric power tool noises, etc. on the concourse during show hours. National Western's commercial vendors begin moving in on Wednesday, January 6.

**National Western does not allow RMQHA vendors to stay over unless approved through the National Western's Commercial Exhibitor Department.**

**THERE ARE ABSOLUTELY NO DOGS ALLOWED AT THIS SHOW.** One free vendor parking pass will be issued per vendor for Lot H. Additional parking passes are \$35 each. Parking passes are required starting on Tuesday January 5. Trailers must be parked off grounds at an additional fee. There is no camping or overnight stay available.

2. **RMQHA Bell Ringer Circuit - National Western Events Center, Denver, CO.** February 24 - February 28, 2010.

Location: Warmup Arena area - Indoor. 10x10 - \$125; 10x20 - \$225; 10x25 - \$275; 10x30 - \$350; 10x40 - \$400.

Location: Concourse-Mezzanine Level - 10 x 10 - \$100; 10 x 20 - \$150.

Move In: No earlier than 10 a.m. on February 23. Move out: Sunday February 28 at 3 p.m. Free parking will be available in Lot H.

Camping/electrical \$25 per night. Dogs are not allowed at the National Western Complex.

3. **RMQHA Gold Rush Circuit - National Western Events Center, Denver, CO.** March 24 - 28, 2010.

Location: Warmup Arena area - Indoor. 10x10 - \$125; 10x20 - \$225; 10x25 - \$275; 10x30 - \$350; 10x40 - \$400.

Location: Concourse-Mezzanine Level - 10 x 10 - \$100; 10 x 20 - \$150.

Move in: No earlier than 10 a.m. on March 23. Move out - Sunday March 28 at 3 p.m. Free parking will be available in Lot H.

Camping/electrical \$25 per night. Dogs are not allowed at the National Western Complex.

4. **RMQHA Colorado Gold Circuit - The Ranch - Ranchway Feeds Indoor Arena - Loveland, Colorado.** April 22-25, 2010.

Outdoor: \$100. Indoor: 10 x 10 - \$60; 10 x 20 - \$100; 10 x 30 - \$125; 10 x 40 - \$150. Camping additional. Move in: no earlier than April 21 - 1 p.m. Move out - Sunday April 25 at 3 p.m. All dogs must be kept on a leash.

5. **COLORFUL Colorado Circuit - The Ranch Indoor Arena - Loveland, CO.** June 9 - 13, 2010. Outside area only. \$100 flat

rate. Inside Indoor arena: Indoor: 10 x 10 - \$60; 10 x 20 - \$100; 10 x 30 - \$125; 10 x 40 - \$150. . Camping additional. Move in no earlier than June 8, 11 am - Move out no later than 4 p.m. June 13, 2010. This show features Palomino & Buckskin Shows as well as AQHA shows. All dogs must be kept on a leash. This show only - make checks payable to Excel Associates.

6. **Youth/Amateur and Summer Spectacular Shows - Colorado Horse Park - Parker, CO.** Show begins June 18 - June 20, 2010. Move In: No earlier than 10 a.m. Thursday, June 17. Move Out: Sunday, June 20 - 4 p.m. All spaces: \$75 each. Vendor Electrical is \$20/day additional. Water is \$15/day additional as charged by the facility.
